**PROGRAM DESCRIPTION:**

This timely seminar will discuss the impact of the recent Court of Appeals decisions in Acevedo upholding the Department of Motor Vehicles regulations 15 NYCRR Part 136.5 for the “three strikes rule” for repeat alcohol/drug related driving convictions or incidents resulting in permanent denial of a driver license or privilege application.
