

Social Security Disability & Veterans' Compensation Benefits



SSD Benefits

Social Security Disability – SSD is a federal <u>total</u> **disability** program, which may or may not be taxable.

Benefits are based on average lifetime earnings, not on household income or how severe the individual's disability is.

Benefit can retro – a year prior to application.

Recipient of SSD benefits may receive additional monies for dependents.

Mandatory waiting period of five months after your disability begins before receipt of benefits can begin.

Max Benefit for individual – 2020 amount \$3,011

SSI Federal Benefit Amount

Supplemental Security Income -SSI is federal total disability program.

Amount of benefits- "means" tested and depending upon the state in which the recipient resides can include additional funds from the state.

Recipient cannot have more than a total of \$1500 dollars in bank account(s)

Can automatically qualify the recipient for other state benefits.

Date benefit retro – date of application

SSI amounts for 2020 The monthly maximum Federal amounts for 2020 are \$783 for an eligible individual.

Veterans' Compensation Benefits

Non-taxable

Based upon degree of the veteran's disability.

Rated from 0% evaluation to 100% evaluation.

VA Compensation Rates

A veteran receiving a less than 30 % evaluation is not eligible to receive compensation for his/her dependents.

Veteran's Pension

Low-income wartime veterans and their survivors may qualify for a tax-free pension.

Eligibility based upon veteran's service time, financial need, and age or status of the veteran or survivor.

This is means tested program

Countable income includes how much is earned, Social Security benefits, investment and retirement payments, and any income your dependents receive. Some expenses, like non-non-reimbursable medical expenses can be used to reduce countable income.

Net worth limit to qualify for a Veterans Pension as of December 1, 2019, is \$129,094.

What To Do

Consider:

What is the veteran's compensation rating

Does the veteran have debilitating conditions outside of those that are service connected

Age of the veteran

Past work experience of the veteran

Is the veteran working

Is there any type of work that the veteran could do

Does the veteran have any transferrable skills

Will there be an offset

What other benefits might the veteran qualify for
